Tariff simplification

Criminal tariff model revised

We are making significant changes to the simplified criminal tariff model based on our analysis and your feedback. These changes will make tariff compensation more equitable in guilty plea situations, while maintaining a reduced number of tariff items, the balance between cases, and overall cost neutrality.

The revised criminal tariff is now posted to our website (Lawyers → Request for feedback on new tariff), with an update paper that provides more detail on this revision. Changes include:

- sentencing made payable each half day consistent with the current tariff,
- increases to multiple information resolution,
- · increases to subsequent half days of trial,
- reductions to the Provincial Court fee, and
- reductions to the non-trial resolution fee.

These changes will re-establish the current balance between summary and indictable proceedings. The original published model created an unintended benefit for indictable cases, to the detriment of summary cases. The changes will more evenly distribute tariff payments between lawyers when compared to the current tariff. A simplified tariff will inevitably create some "winners" and "losers," but we have worked to keep shifts for individual lawyers to acceptable levels. Family model implementation date

We are continuing to work on implementing the simplified family tariff. Consultations on the model are nearly complete; we don't anticipate any changes to the model. The target date for implementation of the new family tariff remains **July 2010**. Referrals issued after the implementation date will be subject to the new simplified tariff. Referrals issued prior to that date will continue to be billed on the older tariff.

CFCSA tariff

Discussions and analysis of the CFCSA tariff continue. We anticipate further work this summer, with implementation of a new, simplified CFCSA tariff in the fall.

Tariff updates

BCMA rates

The online *Guide to Legal Aid Tariffs* has been updated to reflect increases to BCMA fees, effective **April 1, 2010**.

Parking rates

Due to the recent change to PST by Translink (from 7% to 21%), parking rates have been increased to \$16.

Harmonized Sales Tax (HST)

HST of 12% will be applied to all accounts approved by LSS for payment after **June 30**, **2010**, in the same way GST was applied. More details will follow in next month's *LAF*. E-mail questions to helpdesk.finance@lss.bc.ca.
