Local agents appointed

LSS is pleased to announce the successful candidates for the new local agent contracts across the province.

The seven new locations will open March 29, 2010 and will replace five regional centres (closing March 26, 2010). Our new local agents will maintain the same phone numbers as the regional centres in their communities. The local agents will have access to client and file information on current and pending cases. We plan to make this transition as seamless as possible. Further contact information will be distributed locally and on our website.

Tariff simplification

We continue to work on simplifying the Criminal, Family, and CFCSA Tariffs. For details, please see the discussion papers on our website at www.lss.bc.ca/lawyers/newTariff.asp.

Highlights of the Criminal Tariff include:

- Consolidation of current tariff items into 27 billable tariff items
- Classification of offences into Summary, Indictable, and Major (for tariff purposes)
- Introduction of a basic fee for Provincial Court and Supreme Court proceedings
- Creation of a non-trial resolution item that consolidates guilty pleas, stays, and other ways to conclude a case

Highlights of the Family and CFCSA Tariffs include:

- Consolidation of most preparation time into general preparation
- Additional preparation time for Supreme Court proceedings and CCO hearings
- Additional preparation and attendance for mediation and collaborative practice
- Extended Services, which provide a standard allocation of additional time for eligible cases
- Closing fee

Extended Family Services reinstated

Counsel with existing Emergency referrals or continuing Extended Family Services (EFS) referrals can now apply for EFS referrals. We encourage you to apply if your client has taken all reasonable steps to resolve the coverable issues in the case and serious issues remain unresolved. For cases that qualify for EFS, a standard allocation of hours will be provided; we expect you to manage your case within the available budget. We do not intend to issue renewals or additional hours if an EFS authorization has already been approved since the reinstatement of EFS. For details, see Notice to Counsel #72.

Please keep your billings up to date

We encourage you to take the time in March to ensure your billings are up to date. As the end of the fiscal year approaches, we need an accurate picture of our 2009/2010 spending in order to plan effectively for introducing new services in 2010/2011 (see Message to the Bar, December 17, 2009). Today, more than ever, uncertainty about outstanding accounts impedes our ability to plan services.
