Immigration changes

Notice to Counsel #61 announced significant changes to our Immigration Services, including the termination of Refugee Protection Division (RPD) hearing referrals issued on or after April 1, 2008. Referrals issued prior to April 1, 2008 are not affected by this termination. LSS treats the date of assignment (printed on your referral as the Interview/Assignment Date) as the referral date. You can confirm whether your RPD hearing referral is affected by this termination by checking the date of assignment. You should also verify that the service stop date printed on your referral will not affect your continued services to your client. Before LSS will extend service stop dates, clients will need to return to the referring office to confirm that they still qualify financially.

LSS will honour RPD hearing referrals if a hearing date has been set prior to March 31, 2009, provided that the hearing is set before the service stop date on your referral, all services to the client are completed by March 31, 2009, and your final account is submitted to LSS by April 14, 2009. You must also advise LSS of the client's name, the LSS file number, and the hearing date so that we can ensure your referral will not be terminated. Message from Audit and Investigation

In December 2008, LSS introduced two new policies on referral eligibility: the new *Vendor Number Reactivation Policy* sets out the process for reactivating your vendor number, and the new *Vendor Number: Removal or Modification of Conditions Policy* sets out the process for modifying or removing conditions on your eligibility to receive referrals. As a result of these new policies, the *Referral Eligibility Policy* has been amended.

If you apply to reactivate your vendor number or to remove or modify conditions on your eligibility to receive referrals, please fax a completed *Vendor Number Reapplication* form to 604-682-7967 or e-mail it to helpdesk.finance@lss.bc.ca. Notice of bursary opportunities
