# Implementation of the simplified tariffs coming in June

LSS is nearing the completion of the simplified tariff for Criminal and Family matters. The design of the new tariffs has benefitted from input from tariff lawyers around the province. We thank all of you for your input. The exact implementation date near the end of June will be announced soon. We will also post on the LSS website a summary of the final simplified tariff models. A more complete revised Tariff Guide will be posted closer to the actual implementation date. New referrals issued after the implementation date will be subject to the new simplified tariff. Referrals issued prior to the implementation date of the simplified tariff will continue under the current until their stop date (or maximum of 2 years).

#### Tiered rates reinstatement payments

LSS is pleased to advise that the reinstatement payments for tiered rates for criminal duty counsel accounts received between April 1, 2009 and March 31, 2010 were included with the regular May 27<sup>th</sup> tariff payments. # Message from Audit and Investigation – settlement judgment policy

Under our Settlement Judgment Policy, referral lawyers must notify LSS immediately upon learning that a settlement will be received or judgment will be awarded to the client. In addition, you must provide the Audit and Investigation department with the client's current contact information and the amount of the expected settlement or judgment. Referral lawyers must also submit a final account to LSS within 30 days of receipt of the settlement or judgment and a completed Settlement or Judgment Confirmation form.

#### Stats from tariff accounts

Did you know that:

- We receive 10.000 accounts each month
- 92% of accts are received via e-billing and are paid in less than 8 days (an improvement over last year 10-12 days)
- Paper accounts take longer to be paid 19 to 21 days (from when you mail them)
- 84% of lawyers are paid by direct deposit and use My Payments to review payment details (cheque remittance)

### Mentoring program

LSS continues to offer two types of mentoring opportunities for lawyers with less than five years' experience. The goal is to afford practical learning opportunities to lawyers.

Under mentoring assistance, a lawyer with less than five years' experience can ask LSS to authorize a senior lawyer to provide practical advice and feedback on the conduct of a legal aid case. Alternatively, a lawyer with less than five years' experience can request authorization to act as apprentice counsel to a senior lawyer who is working on a complex legal aid case.
